Exhibit A

A limited number of Club 99 memberships at Riverside Golf Course are available to the general public without discriminatory regard to race, religion, gender, sexual orientation, or national origin. Such membership is provided at the discretion of the management of the Golf Club. Prospective purchasers must complete an application and acknowledge an understanding to the terms and conditions of the membership. All memberships are subject to the Club Rules, as they may be amended if needed.

The Club 99 Membership is comprised of the following:

- Price: \$35 per month
- Term: 6 month commitment required, commitment begins on the membership start date. Credit Card will be automatically charged every month for the duration of the membership or a minimum of 6 months from the membership start date. Membership will continue on a month to month basis after the initial 6 month minimum commitment.
- \$16 per round, unlimited green fees with cart, 7 days a week at the start of twilight golf. Twilight times will vary due to factors including daylight savings time changes.
- Unlimited use of practice facilities and range balls at twilight.

In the event that a member requests an early cancellation or termination, the membership may be cancelled and an early termination fee equal to half of the outstanding membership fee to meet the 6 month minimum commitment applies.

Members are required to comply with the Club Rules, as they may be amended if needed. The management of the Golf Club reserves the right to revoke a membership in the event that a member violates the Club Rules. Members are required to pay full tournament rates.
